

Kawana Tennis Club Terms of Agreement

By becoming a member, or participant, of Kawana Tennis Club Inc., you agree to abide by the following Terms of Agreement:

1. Adherence to Club Constitution

All members and participants agree to comply with the Club's Constitution and any bylaws, policies, or rules established by the Club Committee. The Constitution outlines the governance, membership rules, and objectives of the Club.

2. Code of Conduct and Behaviour

All members are expected to uphold the values of sportsmanship, respect, and fairness. The following behaviour is required:

- Treat all players, coaches, officials, and visitors with respect and courtesy.
- Refrain from any behaviour that could be considered abusive, discriminatory, or disruptive.
- Follow all safety and facility rules as instructed by the Club.
- Respect the decisions of the Committee, coaches, officials, and Club contractors.
- Dogs on site must be restrained at all times and are prohibited from being on courts.

The Club reserves the right to take disciplinary action, including suspension or termination of membership, in cases of serious or repeated misconduct.

3. Court Use

The courts are to be used for the purpose of tennis or related activities.

Professional coaching on the tennis courts may not take place, other than by the contracted club coach and by approved persons, who have the prior written agreement of the Committee.

All court users are required to wear non-marking sole shoes which are suitable for tennis.

There is to be no marking of courts for other tennis related activities unless approved in advance.

Skateboards, bikes, scooters or any other non-tennis related items are prohibited on courts.

4. Photography and Media Consent

By participating in Club events, you grant permission for the Club to take photographs and videos that may include your image (or your child's image, if applicable) for the purposes of:

- Promotion and marketing of the Club (e.g. on the Club website, social media, newsletters).
- Documenting and celebrating Club events and achievements.

If you do not consent to the use of images, you must notify the Club in writing via email or by submitting a non-consent form.

5. No smoking

Kawana Tennis Club is a non-smoking and non-vaping environment in and around the facilities.

6. Good Behaviour

Participants at Kawana Tennis Club are required to be respectful and courteous to all who attend these facilities. This includes our neighbours; where noise, parking and general behaviour is to be considered at all times.

7. Privacy and Data

Personal information collected by the Club is handled in accordance with relevant privacy laws and used only for purposes related to Club operations, such as communication, registration, and safety.

8. Public Liability Insurance

Tennis is an unsupervised activity, except for organised coaching programs and activities, and players participate at their own risk.

However, the club does have Public Liability Insurance via our Tennis Queensland affiliation, with \$30,000 cover.

By registering with the Club or participating in any Club activity, you confirm that you have read, understood, and agree to abide by these Terms of Agreement.
